Sub: **Issuance of online NOC for transfer of registration u/s 46A of the Dentists Act, 1948 - regarding.**

Sir/Madam,

I am directed to state that the DCI has, in order to make the process hassle free in getting the NOC by the applicant seeking his/her name transferred as per provision of section 46A of the Dentists Act, 1948, from one state dentists register to another state dentists register, made an online portal. All the persons who are registered in part-A of the State Dentists Register and interested to seek their name transferred to another State Dentists Register, are now required to apply through the online portal of DCI. The NOC of the DCI for the purpose, in reference to the details submitted by the applicant, including the NOC from the parent State Dental Council/Tribunal on this portal **which will be effective from 1st October, 2017,** will be sent to the concerned applicant at his/her email ID as well as to the parent State Dental Council/Tribunal and the transferee State Dental Council/Tribunal of the applicant, for the purpose; thereafter, the transferee State Dental Council/Tribunal, will process the request of the applicant further based on the NOC sent by DCI at their respective email IDs, after verifying the other details of the applicant as per the rule/regulations and guidelines framed by the State Dental Council/Tribunal.

2. Besides the above, I am also directed to say that if any applicant who may not be aware to fill his/her request online and approaches to your State Dental Council/Tribunal, for the purpose, be asked to apply online to DCI.
